- 1. Provisionally Eligible candidates are requested to bring a set of self-attested photocopies of the following documents (as applicable), along with original certificates (the original will be returned after verification) on the date & day of the Interview & Examination.
  - Provisionally Eligible candidates to make sure that they bring the relevant (i) certificate/document in support of their candidature. If at any stage, it is found that the candidate has submitted wrong information in Application form, then the candidature will (ii)
  - Date of birth certificate.
  - Marksheets and Certificates in support of the prescribed educational qualifications (iii)



- Experience Certificate as mentioned in your application (clearly indicating designation, (iv) from (date) pay details etc. Offer of appointment shall not be accepted as proof since the duration of service etc can't be ascertained) as applicable.
- Caste/category certificate i.e. SC, OBC, EWS, PwD, ESM etc., if applicable (v)
- Certificate in support of age-relaxation. (vi)
- No Objection Certificate from present department, if working in Govt organizations/ (vii) Autonomous bodies/PSUs etc.
- Failure to produce the original and prescribed documents in support of eligibility criteria (viii) for the post at any stage shall debar the candidate for appearance in the recruitment process for the post. No representation shall be entertained in this regard.
