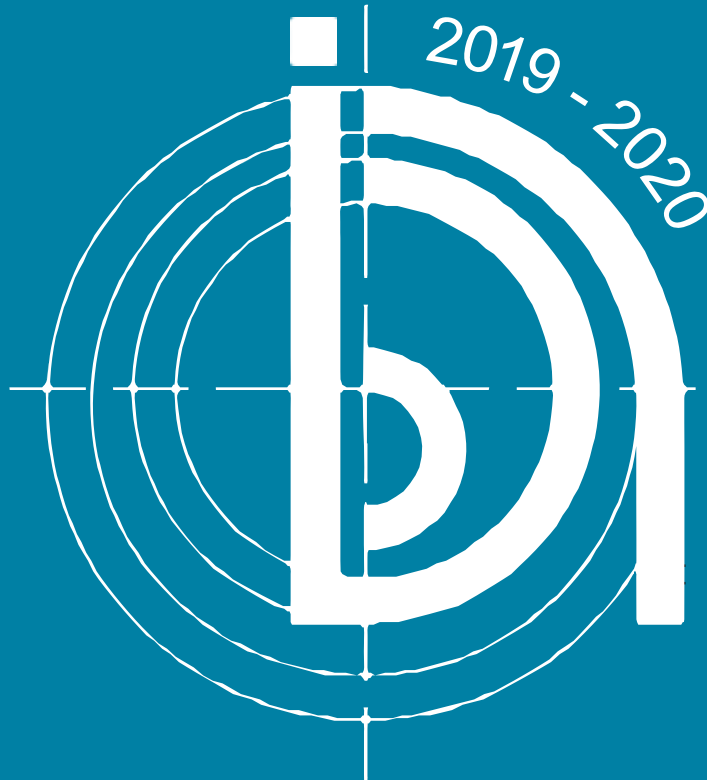

1. INTRODUCTION

1.1 About Us

In 2007, Department for Promotion of Industry and Internal Trade (erstwhile Department of Industrial Policy and Promotion), Ministry of Commerce and Industry, Government of India had envisioned the National Design Policy to create a design-enabled innovation economy and to strengthen design education in the country.

With design and innovation taking prime importance in many sectors, policies, and schemes of the government such as Make in India, Skill India, Digital India, Startup India and Smart City initiatives, it is imperative to promote design education to the next level. India needs the skill and expertise of professionally-trained designers to achieve the missions of the schemes initiated by Central Government.

The National Design Policy had recommended setting up of design institutes on the lines of NID, Ahmedabad in various parts of India

to promote design programmes. Under this Plan, four new NIDs have been set up and NID Madhya Pradesh (NID MP) is one among them. Establishing new NIDs as institutions of national importance in different geographical regions of the country will help to produce highly skilled manpower in design. It will create job opportunities, both direct and indirect, through sustainable design interventions for crafts, handloom, rural technology, small, medium and large scale enterprises. Also, its outreach programmes would assist in capacity, capability and institution building.

NID MP commenced its first academic session in July 2019 with 57 students in its own campus located at Acharpura Village, Eint Khedi, Arwaliya (Post Office), Bhopal, Madhya Pradesh.



1.2 Ministry of Commerce and Industry & DPIIT

The Department for Promotion of Industry and Internal Trade (DPIIT) established in 1995 was reconstituted in 2000 with the merger of the Department of Industrial Development. Earlier separate ministries for Small Scale Industries, Agro and Rural Industries (SSI & A & RI) and Heavy Industries and Public Enterprises (HI & PE) were created in 1999. The Department

was earlier called Department of Industrial Policy Promotion and was renamed DPIIT in January 2019. In 2018, the matters related to e-Commerce were transferred to the Department and in 2019, the Department was given charge of matters related to internal trade, welfare of traders, startup organisations and their employees.

Allocation of Business Rules

According to the Allocation of Business Rules, the Department is responsible for determining the industrial policies at national level, including following matters:

- Productivity in industry,
- Industrial management,
- Matters related to E-commerce and startups,
- Facilitate ease of doing business,
- Promotion of internal trade including retail trade, welfare of traders and their employees, and enacting Administration of Industries (Development and Regulation) Act, 1951, grant of Industrial Licenses and acknowledging industrial entrepreneurs memorandum.
- The Department also administers six acts related to the Protection of Intellectual Property Rights. It also handles matters related to Foreign Direct Investment (FDI) and Investment by NRIs, and promotes investment for industrial development of the country. There are five territorial divisions for international cooperation and industrial promotion to handle matters related to America, Europe, CIS countries, Africa, Middle East, Asian- and Oceania countries.
- The Department is also responsible for promotion and development of sectors related to cables, light engineering industries, Light Industries, Light Electrical Engineering Industries, paper & newsprint, tyres and tubes, salt, cement, ceramics, tiles, glass, leather goods, soaps & detergents and other industries not covered by other ministries or departments.

The following Acts are administered by the Department:

- The Industries (Development and Regulation) Act, 1951
- The Explosives Act, 1884
- The Inflammable Substances Act, 1952
- The Boilers Act, 1923
- The Copyright Act, 1957
- The Patents Act, 1970
- The Design Act, 2000
- The Geographical Indications of Goods (Registration and Protection) Act, 1999
- The Trademarks Act, 1999
- The National Institute of Design Act, 2014

The National Design Policy was approved by the Government on 8 February 2007. The details of the policy, inter alia, include promotion of Indian design through a well-defined and managed regulatory, promotional and institutional framework.

The policy lays special focus on upgradation of existing NIDs, design institutes and human resources to international standards and aims to spread quality education in designs to all regions of India. To achieve this, in 2007, the cabinet approved to set up four National Institutes of Design at Bhopal, Kurukshetra, Jorhat and Vijayawada. They are set up as autonomous and are mandated to address the regional and national requirements.

1.3 NID's Mandate



The mandate of NID is to offer world class design education and to promote awareness of quality designs and their application thereby raising the quality of life. It is embodied through:

- Creating design professionals of excellence to meet India's diverse design needs.
- Training design trainers, enhancing the design skills of other institutions and promoting design education and research in tune with global environment.
- Increasing the number of quality design professionals and faculty, through existing and new institutional mechanisms.
- Becoming a repository of design knowledge, experience and information on products, systems, materials, design and production processes related to traditional as well as modern technologies.
- Encouraging the indigenous design solutions and products for everyday use at affordable cost.
- Ensuring that professional designers are placed in key sectors of national importance to raise standards of design education and practice.
- Offering integrated design consultancy services and innovative design solutions, with the participation of students, as a revenue earning strategy.
- Creating and providing design inputs, products, services, processes, systems, etc. for multi-disciplinary fields like science, technology, management to raise the quality of life.
- Integrating the physical world with the virtual and digital worlds through better information and interface design.
- Providing design intervention for craft and handloom sector, rural technology, small-, medium- and large-scale enterprises through outreach programmes and thereby generating employment opportunities.

1.4 National Institute of Design Act



National Institute of Design, Madhya Pradesh was brought under the ambit of National Institute of Design (Amendment) Act, 2019 (No 38 of 2019) after the assent given by President of India on 29 November 2019. The Act was published in the Gazette of India on 3 December 2019 and come into force vide a Government Gazette notification dated 13 January 2020. NID MP is now eligible to offer Bachelor Degree in Design (B Des), Master Degree in Design (M Des) and PhD Degree in Design. Subject to the provisions of this Act, the institute shall exercise the following powers and perform the following duties:

- Provide education, training and research facilities in the areas or disciplines relating to design, to nurture and promote quality and excellence.
- Develop courses leading to graduate, postgraduate degrees, doctoral, post-doctoral distinctions, to hold examinations, grant degrees, diplomas and other academic distinctions or titles in the areas or disciplines relating to design.
- Confer honorary degrees, awards or other distinctions in the areas or disciplines relating to design.
- Constitute and award fellowships, scholarships, prizes and medals.
- Fix, collect fees and other charges.
- Construct, maintain and manage hostels for the residence of the students.
- Supervise, cultivate discipline of students, promote health, general welfare to lead a balanced cultural and corporate life.
- Constitute academic and other posts and to make appointments thereto (except Directors).
- Acquire any patent or license relating to such invention, improvement or design or standardisation marks for general or specific purposes.
- Undertake consultancy in the areas or disciplines relating to design.

-
- Deal with any property belonging to, or vested in, the Institute, in such manner as the Institute may deem fit for advancing the objects of the Institute.
 - Receive gifts, grants, donations or benefactions from the Government and to receive bequests, donations and transfers of movable or immovable properties from testators, donors or transferors, as the case may be.
 - Encourage and improve education of persons who are engaged or are likely to be engaged in the service, training or research activities by grant of loans, scholarships or other monetary assistance or otherwise.
 - Prepare, print, publish, issue, acquire and circulate books, papers, periodicals, exhibits, films, slides, gadgets, circulars and other literary undertakings, dealing with or having a bearing upon the subject of industrial design and allied fields.
 - Establish and maintain museums, libraries and collections of literature and films, slides, photographs, prototypes and other information relating to design and allied subjects.
 - Frame Statutes and Ordinances and to alter, modify or rescind the same.
 - Cooperate with educational or other institutions in any part of the world having objects wholly or partly similar to those of the Institute by exchange of faculty members and scholars and generally in such manner as may be conducive to their common objective.
 - Act as a coordination centre between academia and industry by encouraging exchange of designers and other technical staff between the Institute and the industry and by undertaking sponsored and funded research as well as consultancy projects by the Institute.
 - Establish, equip and maintain workshops or laboratories or studios with modern machinery and equipment in order to undertake scientific and technological research for creating good designs for the production of goods and services and to provide funds for such works and for payment to any person or persons engaged in service, training and research work whether in such workshop or laboratory or studio.
 - Nominate designers, engineers (mechanical or electrical or civil), architects, craftsmen, technicians or investigators to study in India or outside India in regard to the service, training and research in such fields as the Institute may think fit.
 - Retain or employ skilled professional, technical advisers, consultants, workers or craftsmen in connection with the objectives of the Institute.
 - Encourage artisans, technicians and others with inventive skills to work out details and specifications of processes, appliances and gadgets by giving awards, financial or technical assistance.
 - Borrow and raise money, with or without security or on the security of a mortgage, charge, or hypothecation or pledge of any of the movable or immovable properties belonging to the Institute or in any other manner.
 - Construct buildings and alter, extend, improve, repair, enlarge or modify and to provide and equip the same with all other amenities related with them.
 - Do all such things as may be necessary, incidental or conducive to the attainment of all or any of the objects of the Institute.

1.5 Institute of National Importance (INI)



Institute of National Importance (a status conferred on a premier public higher education institution in India by an act of Parliament of India, an institution which “serves as a pivotal player in developing highly skilled personnel within the specified region of the country/state”. Institutes of National Importance receive special recognition and funding from the Government of India.

NIDMP is accorded as an “Institute of National Importance” by an Act of Parliament, under the National Institute of Design Act, 2014 and its subsequent amendments. Through the amendment of NID Act, 2014 four new National Institutes of Design—1. National Institute of Design, Amaravati/Vijayawada, Andhra Pradesh, 2. National Institute of Design, Bhopal, Madhya Pradesh, 3. National Institute of Design, Jorhat, Assam and 4. National Institute of Design, Kurukshetra, Haryana—were given the status of Institutions of National

Importance (at par with the National Institute of Design, Ahmedabad).

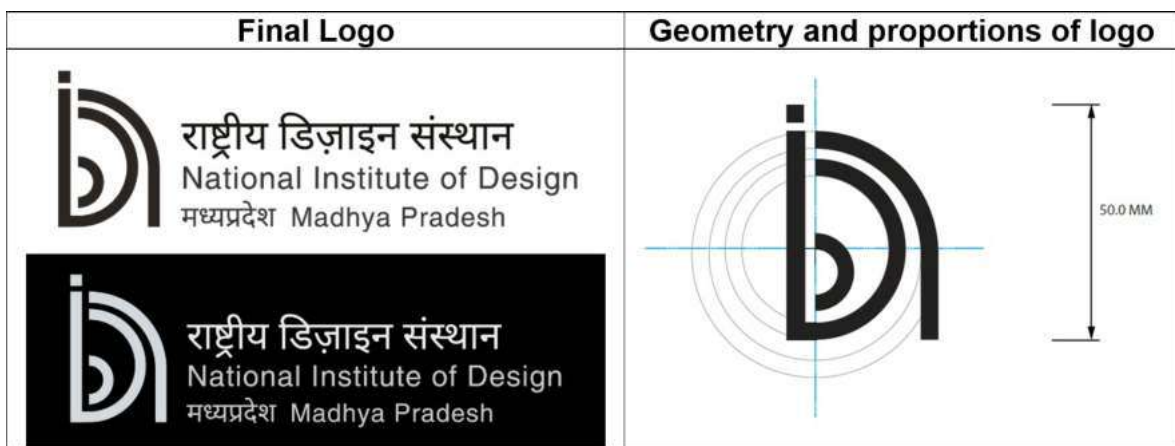
The amendments to the Act included renaming NID Bhopal as NID, Madhya Pradesh and treating the nomenclature of Principal Designer as equivalent to Professor. As of 2020 there are 159 institutes, declared as Institutes of National Importance. It includes 23 IITs, 15 AIIMSs, 20 IIMs, 31 NITs, 25 IIITs, 7 IISERs, 7 NIPERs, 5 NIDs, 3 SPAs, 5 central universities, 4 medical research institutes and 14 other specialized institutes.

Establishing new NIDs as Institutions of National Importance in different regions of the country will help to produce highly-skilled manpower in design which in turn will create direct and indirect employment opportunities, provide sustainable design interventions for crafts and handloom sector, rural technology, small-, medium- and large-scale enterprises.

1.6 Branding of NIDMP

The legacy of brand NID goes back to early 1960s. Under the National Institute of Design Act, 2014 and its subsequent amendments, all four new NIDs got their eminent status at par with NID Ahmedabad. All new NIDs are mandated to be autonomous and to create their own identity with their portfolios and activities more relevant to their design needs, concerns of geographic location, with a social and industrial impact on national and global scale. To build its brand, through NBCC,

M/s Grau Bar Design, Indore was empaneled to work with Director of the institute to design the Logo of the institute. The Logo of NID Bhopal was approved by Governing Council in its first meeting on 29 May 2019. Subsequent to the cabinet's approval, DPIIT communicated renaming of the institute from NID Bhopal to NID Madhya Pradesh and the same was approved by Governing Council in its second meeting on 23 July 2019.

The Creator is considered as the first geometer of the world and entire cosmos has been created with divine proportions.

NID, Madhya Pradesh's monochrome logo is thus designed with geometry as its base for faithful reproduction across all media, format and scale without losing its appeal. As circles represent completion, wholeness and harmony, hence the first alphabets of all words from the name of the institute are taken to compose it for a wider appeal and acceptance with circle as its formation base.

Meaning behind various elements and composition in logo

Following fonts are used in the logo formation.

- Hindi font: NOTO SANS, and
- English font: Helvetica

Three Circles in the logo represents: Mandate of NIDMP to be relevant to industry and society is at the core of its philosophy and this

value is embedded in its identity (logotype) formation. This becomes a constant reminder to perpetually serve them.

- Smallest circle represents the institute.
- 2nd circle represents industry,
- 3rd circle represents the entire society and global community.
- All three circles together with off centric alignment represents growth and continuity.

CIRCLE

The circle is a universal symbol representing the notion of totality, wholeness, perfection, eternity and timelessness. It symbolizes the cycle of time and the perpetual motion of everything that moves. It moves without restriction, suggesting energy and power. It rolls freely, representing the infinite and oneness. While it moves freely, it protects what's inside its boundaries. It represents defence, endurance and safety.

BLACK

Black colour has a special full-spectrum status when it comes to the feelings it reflects.

It is required for all other colours to have depth and variation of hue. It is associated with power, mystery, strength, authority, elegance, formality and sophistication. Black used in contrast with white creates energy. It bears huge communicative potential for transmitting information.

WHITE

The colour white symbolizes goodness, cleanliness, purity, clarity and innocence. It also represents a sense of optimism, equality, energy, simplicity, openness, truth, peace, idealism, freshness and minimalism.



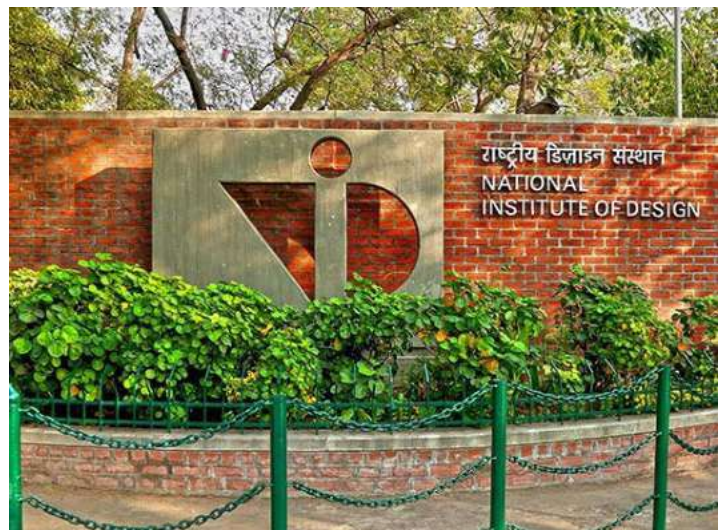
1.7 Genesis of Design in India

To design and make things look good and comfortable is the most basic instinct of humans; it is genetically coded and transferred through our genes. From Pangaea to great nation India has been an overwhelmingly intellectual journey. This transference of knowledge has been instrumental in developing instincts, impulses, desire, etc as they get triggered by monumental events. The seed and soil theory validate this point of view. Thus, Design probably can be considered as the oldest profession known to the humans and has been the cradle of birth and genesis for all other disciplines. Archaeological evidences of design can be found at almost all the archaeological sites across the world. For any product, the design is an intrinsic and inseparable part of it. Thus the producer of every product is a creative person and all creative persons are designers.

1.8 History of NIDMP

The National Design Policy recommended setting up design institutes on the lines of NID, Ahmedabad in various parts of India to promote design programmes. In 2013, government decided to set up four new NIDs, each in Madhya Pradesh (Bhopal), Andhra Pradesh (Amaravathi), Assam (Jorhat), and Haryana (Kurukshetra) at par with NID Ahmedabad.



With the untiring efforts of NID section officials at DPIIT, NIDMP is the first one to get its land on 13 September 2013. Mr. Anand Sharma, then Union Minister of Commerce Industry, laid the foundation stone of NIDMP. Mr. Pradyumna Vyas, Director, NID Ahmedabad and Mr. Siddhartha Swaminarayan (Head, Administration, NIDA) visited the proposed site.

Prof. Dhiraj Kumar was appointed as the first Director of the NIDMP and he took charge on 7 January 2019.

- Boundary wall construction work was carried out by CPWD, Bhopal region.
- In 2016, campus construction commenced.
- On 1 February 2016 the cooperative society of NID Bhopal was constituted for registration purpose under MP Societies Registration Act, 1973 for grant of statutory status to the society. Office of the society (S No 01 01 02 30548 16) was situated in the office of Secretary, Department of industries, Mantralaya Vallabh Bhawan, Bhopal.
- Around this time a draft Bill, to amend the NID Act, has been prepared as it is only by this process of legislation that the Parliament can declare an institution for scientific or technical education as an Institution of National Importance under Entry 64 of the Union List in the Seventh Schedule of the Constitution of India.
- Directors for the new four NIDs were appointed in December 2018 (NID section at DPIIT coordinated the entire process of appointments of Directors).

2. STATUTORY BODIES

2.1 Governing Council and Members

Governing Council is the apex body of the institute as defined under section 10 of the NID act 2014. Following decisions were taken in the first Governing Council meeting held on 29 May 2019.

- Interviews for 15 vacancies in 6 posts and selection of 3 Senior Faculty, 3 Associate Senior Faculty, 6 Faculty, 1 Registrar, 1 Controller of Finance Accounts and 1 Chief Administrative officer were conducted successfully.
- Approval of Logo for NID Bhopal Madhya Pradesh.
- Decided to adopt the 103rd Constitutional Amendment to provide 10% reservation to economically weaker sections (EWS). For this, it was decided to increase the intake of students by 25 percent from academic Year 2020–2021 in all the programs offered and the Director was directed to create provisions for additional resources in the campus accordingly.
- Decided to submit the budget estimates for 2019–20 to DPIIT.
- Approval of authorised signatories of the following authorities—Director, Registrar, Controller of Finance Accounts, Head Librarian/Resource Centre.
- Decided to implement the Medical and Children Education Allowance schemes as per the latest government of India rules.
- Decided to adopt the National Pension Scheme as per latest government order.
- Decided to follow the NID Ahmedabad General Service Rules till NID Bhopal creates its own standard operating procedures and manual.
- Decided to increase the fees by 7% annually for all academic programs.



The Governing Council of the Institute consists of the following members:

- A Chairperson, who shall be an eminent academician, scientist or technologist or professional or industrialist, to be nominated by the Visitor.
- The Director, ex officio.
- Financial Adviser in the Ministry or Department of the Government of India dealing with the National Institute of Design, ex officio.
- Joint Secretary in the Ministry or Department in the Government of India dealing with the National Institute of Design, ex officio.
- One representative of the Ministry or Department of the Government of India not below the rank of Joint Secretary dealing with Higher Education, to be nominated by the Secretary of that Ministry or Department, ex officio.
- One representative of the Ministry or Department of the Government of India not below the rank of Joint Secretary dealing with Information Technology to be nominated by the Secretary of that Ministry or Department, ex officio.
- One representative from the State in which the campus of the Institute is located, to be nominated by that State Government.
- Five professionals, one each from the fields of architecture, engineering, fine arts, mass media and technology, to be nominated by the Central Government.
- An outstanding Designer, to be nominated by the Visitor in consultation with the Central Government.
- A management expert, to be nominated by the Chairperson.
- A representative of the Micro, Small and Medium Enterprises, to be nominated by the Central Government.
- Three persons to be nominated by the Senate from amongst persons recommended by companies, firms or individuals who have provided financial assistance or contribution to the Institute; provided that the threshold of financial assistance or contribution and other requirements to qualify for such nomination shall be such as may be provided for in the Statutes; and
- Dean of each Institute campus, ex officio.

2.2 Standing Committee of GC

The Standing Committee is constituted by the Governing Council.

- All policy matters requiring consideration and approval of the Governing Council and all matters pertaining to service conditions of the employees of the Institute shall be first placed before the Standing Committee for consideration, recommendations, or approval.
- All proposals seeking budgetary support, whether recurring or non-recurring, from the Government of India shall be reviewed by the Standing Committee and recommendations shall be made by the Committee to the Governing Council.
- The Standing Committee shall also function as Finance Committee and Building and Contracts Committee and shall review periodically all major building or construction projects, contracts and work orders in respect of major items of capital expenditure, and such other matters as may be decided by the Governing Council.
- The Standing Committee reviews and give recommendations on all such financial and policy matters as may be referred to it by the Governing Council.
- All minutes of the proceedings of the Standing Committee or Resolutions of the Standing Committee are placed before the ensuing meeting of the Governing Council for noting or ratification or consideration.
- All orders and decisions of the Standing Committee shall be signed by the Chairman, authenticated and circulated by the Registrar or any other person authorized by the Governing Council to the members of the Committee.



2.3 The Senate

The role, powers and functions of the Senate are given below.

- Framing and revising curriculum and syllabus for the courses of studies for various disciplines and making any changes thereof, as per the recommendations of the Academic Advisory Committee.
- Making recommendations to the Governing Council regarding the creation, restructuring or abolition of disciplines or programmes or campuses.
- Overseeing the arrangements for the conduct of examinations, appointment of examiners, moderators, tabulators and other matters relating to examinations.
- Declaring the results of final semester examinations or appointing committees or officers to do so and making recommendations to the Governing Council regarding conferment or grant of degrees, diplomas and other academic distinctions or titles.
- Appointing committees or working groups from amongst the members of the Senate, other faculty members and experts from outside to advise on specific and important academic matters.
- Considering recommendations by Academic Advisory Committee and taking action or recommending for a course of action.
- Periodical review of activities of various faculty streams or disciplines and taking appropriate action for maintaining the excellence of standards of education of the Institute.
- Promoting design research and development in classrooms and fields and encouraging opportunities through consultancy, outreach and Industry Programme projects.
- Planning and reviewing electives and other extracurricular programmes of students and making appropriate recommendations.
- Overseeing the functioning of labs, studios, classrooms, hostels, student welfare, co-curricular activities and grievance-redressal mechanisms.
- Awarding stipends, scholarships, medals, prizes and other similar recognitions with such conditions as may be deemed necessary.
- Periodical review of the progress of various activities of the Institute.
- Constitute Admissions Committee to frame rules, eligibilities, formats, weightage and procedures, including outsourcing of various administrative and logistic activities through reliable and reputed agency or agencies for the conduct of admissions or entrance tests for various programmes of the Institute and consider its recommendations for implementation.
- Inviting two student representatives to the Senate meeting during discussion of matters relating to student welfare, not involving any policy or disciplinary matters.
- Set the criteria for the termination of academic programs and approve each termination with due deliberation.
- Appoint such other committees (both permanent and ad hoc) as may be necessary, to carry out specific tasks that may be laid down by the Senate. The members of such committees shall be nominated from amongst the members of the Senate, other faculties of the Institute, students of the Institute, and experts from outside the Institute in accordance with the procedures that may be laid down by the Senate from time to time.
- Inviting such person or persons as may be deemed fit to attend a meeting of the Senate.

2.4 Faculty Forum

The Faculty Forum is an advisory body and shall consist of all teaching faculty members of the Institute.

The Faculty Forum shall meet at least twice in a year, preferably prior to the beginning of the academic semester, and deliberate on all academic matters to strengthen the vision of the educational programmes, updating the curriculum, consistently raising educational

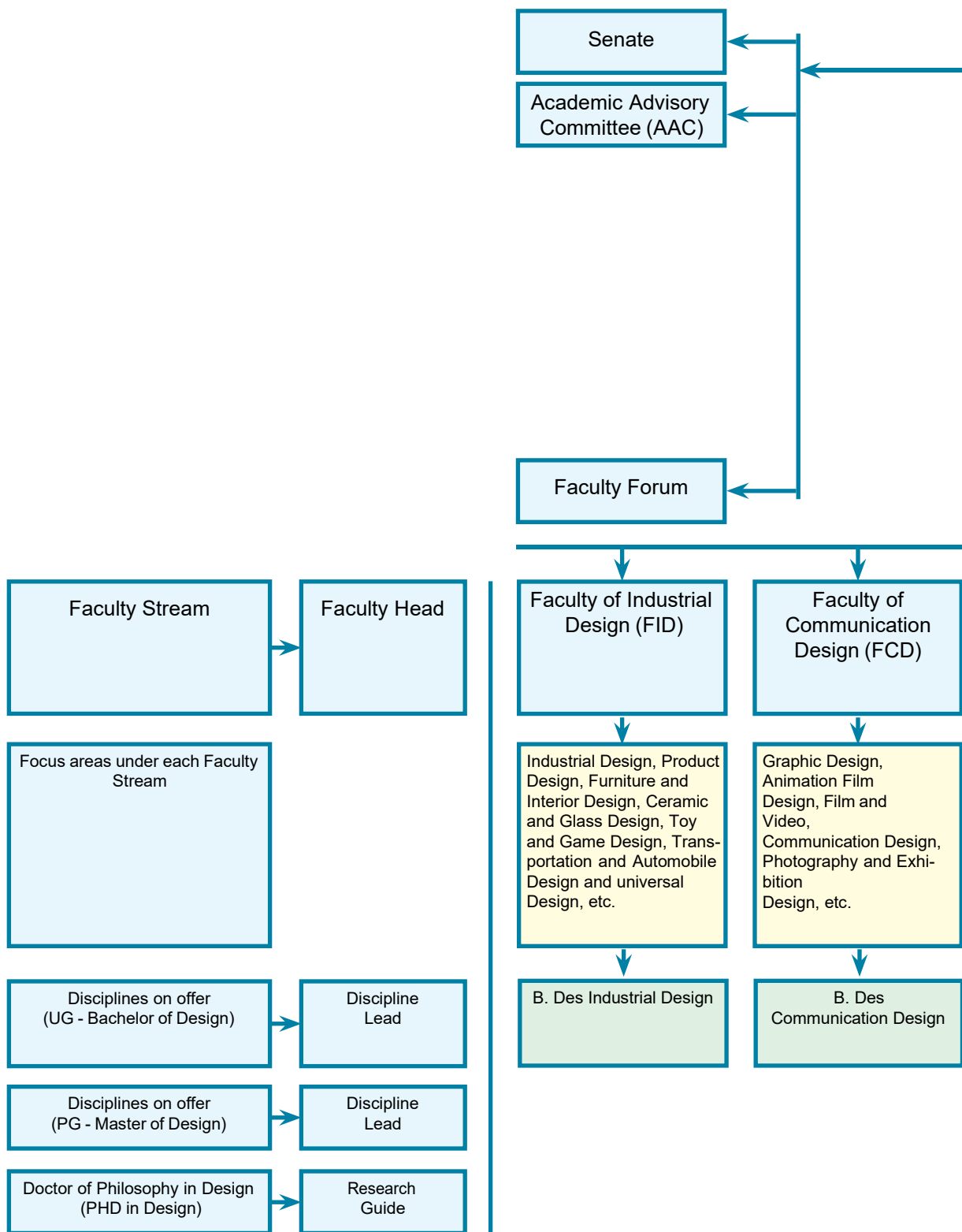
standards and give feedback to the Senate on the course delivery, evaluation and juries.

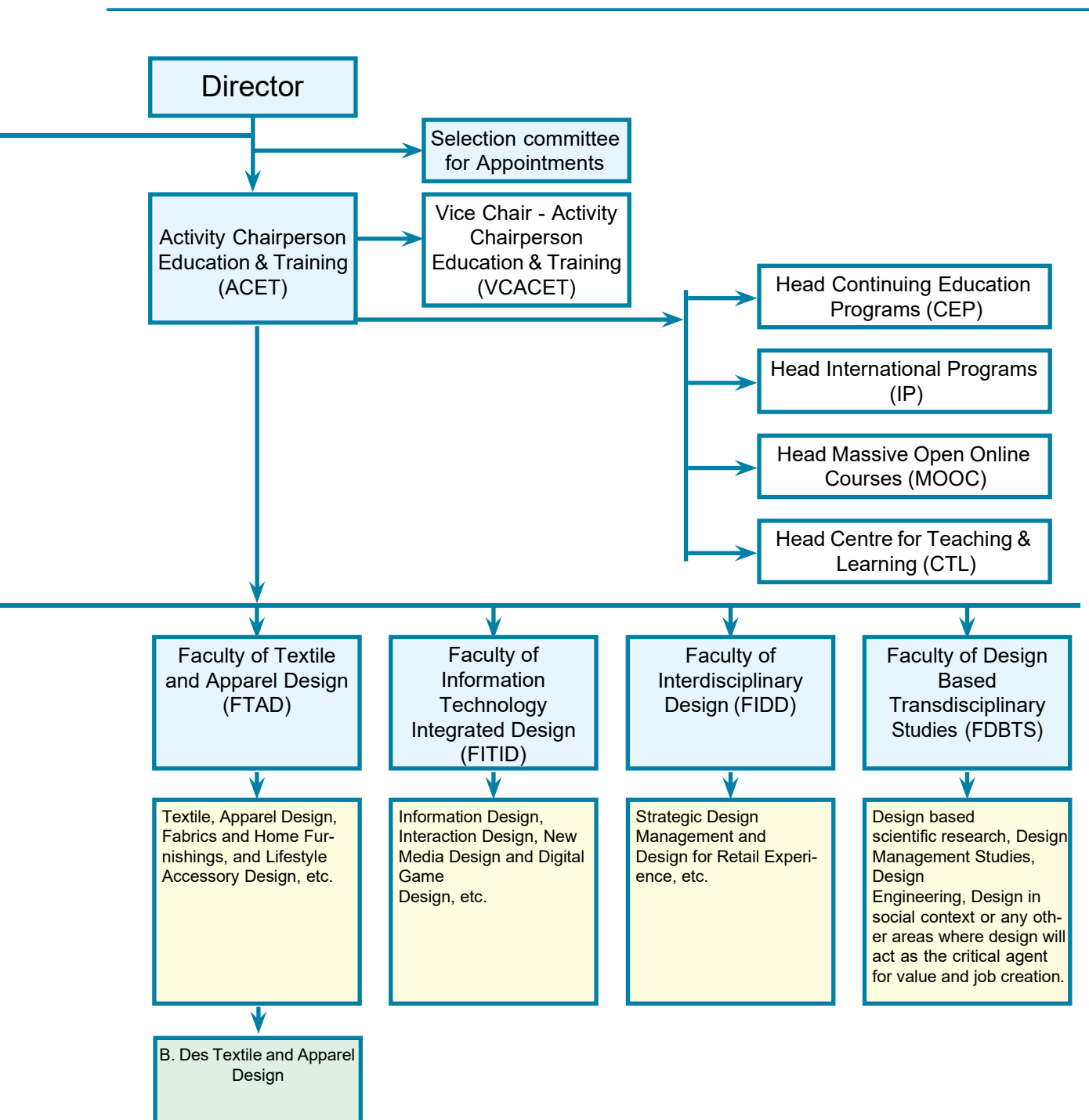

3.1 Faculty Stream

Faculty Stream is an academic unit of the Institute engaged in academic activities such as design education, consultancy, research and development.

The Institute offers education programmes under the following Faculty streams through various Design Disciplines at UG, PG, and PHD levels. The broad focus area of each faculty stream is:

Faculty of Industrial Design (FID)

It is a dedicated team of extraordinary, innovative leaders who will bring new levels of creativity, vision, and integrity to the Discipline. This extremely diverse Discipline delivers competitive edge in learners through design. The programmes offered under this stream teach about creating concepts of designing products, devices, machinery and services. The Discipline ultimately aims to present to the customers user-friendly products with value and utility such as furniture, interior items, ceramic and glass products, toys and games, automobiles, etc.

Faculty of Communication Design (FCD)

Faculty of Communication Design deals with the extremely diversified media and multimedia platforms. Design communication skills are developed to enable a learner to use arts and technology for communicating ideas. Students are taught the theory and practice needed to combine words, images and expressions to visually transmit information and project human experiences. The team is specialized in Graphic Designs, Animation, Film and Video Communication Design, Photography and Exhibition Design, etc.

Faculty of Textile and Apparel Design (FTAD)

Faculty of Textile and Apparel Design is a unique stream addressing textile, apparel, fashion and interior accessories product designs. The programmes under this stream strikes a balance in the domains of textile products development, apparel designing, lifestyle and fashion accessories and their merchandising. The programs offered under this stream are deep rooted in scientific processes of textile development, garment manufacturing technology, lifestyle and fashion accessories and its design. Students are trained to develop best standards both in traditional handcrafted

sector and sophisticated modern technology-based textile, apparel and accessories industry. Faculty are specialised in textile, apparel, lifestyle fashion and accessory designs.

Faculty of Information Technology Integrated Design (FITID)

Faculty of Information Technology Integrated Design stream offers programs which are conceptualized around Information technology-based designs and offers design solutions with focus on design industry of future. This stream keeps track of emerging design scenarios to train students as innovators, who could understand requirements of the industry and apply design in creative ways to act as problem solvers. The faculties are specialised in Information Design, Interaction Design, New Media Design and Digital Game Design, etc.

Faculty of Interdisciplinary Design (FID)

stream focuses on the design-based need of non-design disciplines such as science, engineering, management, etc. and addresses them through specialized programs. Ideally most of the programs offered under this stream are considered as postgraduate studies, however in some cases, they may be offered at undergraduate level with suitable justifications. The programs offered under this stream are based on the belief that successful leadership require a broad understanding of the relationships between technology and people to foster and develop graduates who will be able to address and tackle major challenges that faces the society with transformative and multidisciplinary solutions. The team is specialised in design engineering, strategic design management and design for retail experience, etc.

Faculty of Design Based Transdisciplinary Studies (FDBTS)

This stream focuses on Design-based Scientific Research, Design Management studies, Design Engineering, Design in social context, or any other areas where design will act as the critical agent for value and job creation.

1. Functions of Activity Chairperson— Education Training

- In charge of all administrative and academic activities of educational programmes with respect to all Faculty Streams and Programmes.
- Responsible for maintaining excellence in standards of education, including students disciplinary matter and grievances, through appropriate action in consultation with the Senate, Director, Council's Standing Committee and the Governing Council.
- All deans, faculty heads, discipline leads, lab or studio coordinators and faculty members across the disciplines or programmes and all advisory committees related to education and academics including admission committee, credit and evaluation committee, and education Panel has to coordinate with Activity Chairperson (Education Training) for delivery and maintenance of academic standards of the Institute.
- Chairs the committees and panels constituted by the Director and carry out tasks and functions entrusted by the Director.

2. Functions of Activity Chairperson— Strategy Planning

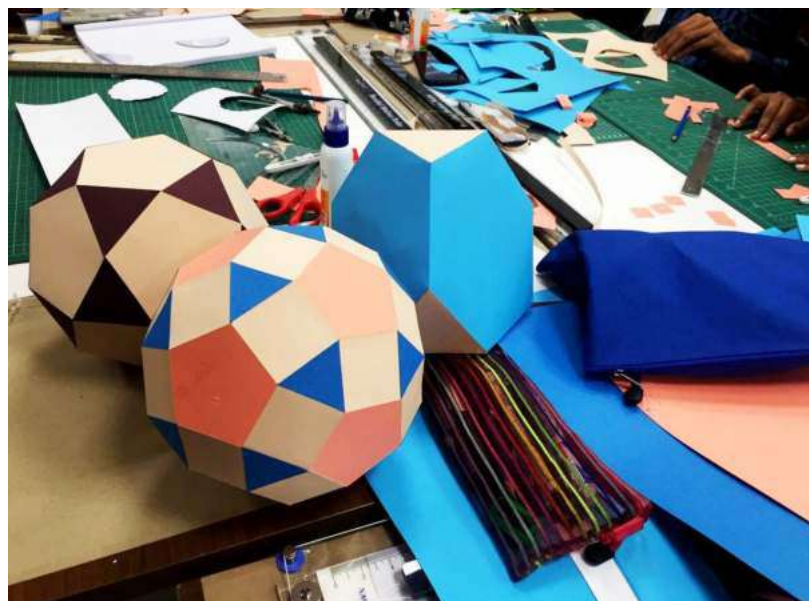

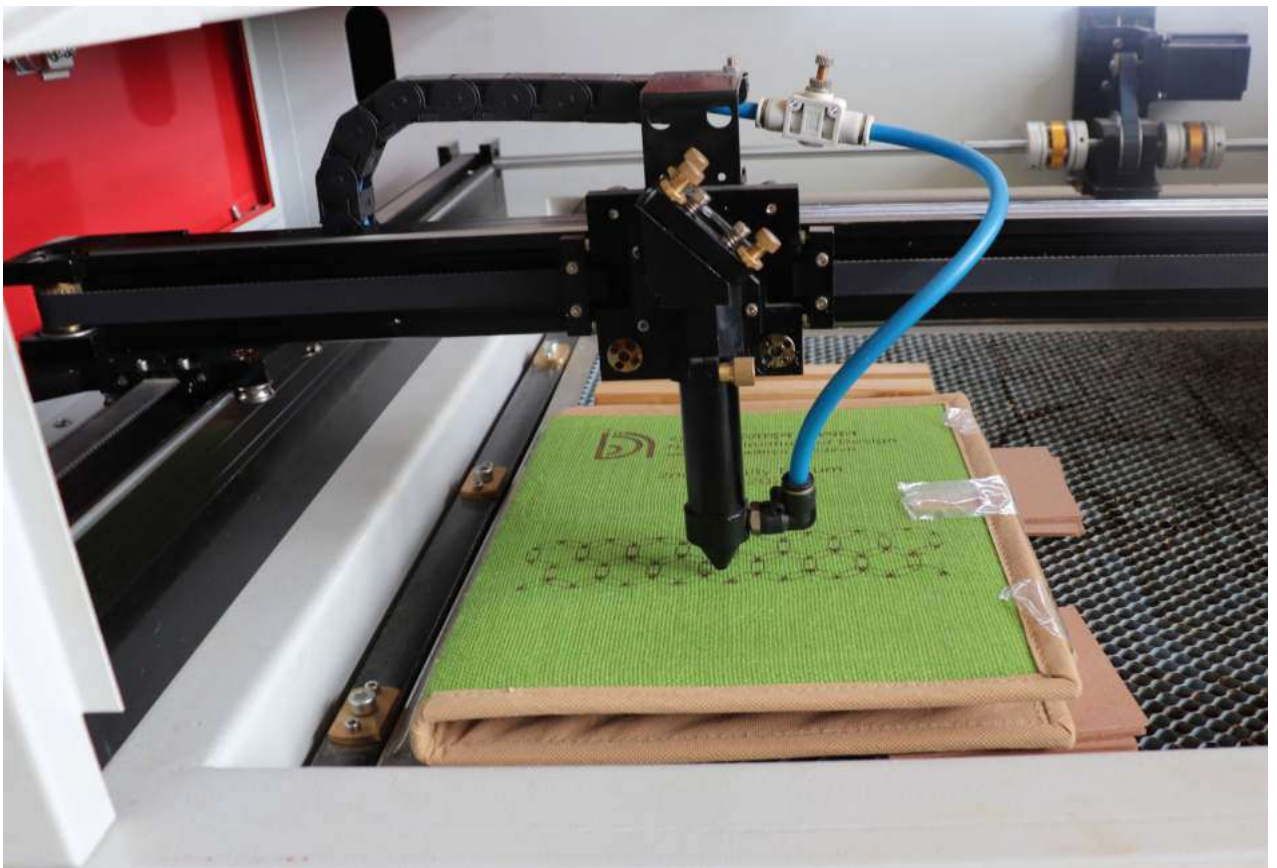

4.2 Bachelor of Design [B.Des (Industrial Design), 3 years]

Industrial Design (ID) program is dedicated to enable the learning and development of extraordinary, innovative leaders who will bring new levels of creativity, vision, and integrity to the discipline. This extremely diverse program delivers to develop competitive edge in learners to be industry ready for all mass production-based industry through design. The program not only prepares to focus on the appearance of a product, but also on how it functions, is manufactured and ultimately the value and experience it provides for users.







4.3 Bachelor of Design [B.Des (Communication Design), 3 years]

Communication Design (CD) program deals with the extreme diversity that lies within the broad spectrum of this discipline. System-based approach is delivered dealing with the totality of media and messages within the culture or an organisation as a singular integrated process. Design skills are accordingly developed to be customised to specific orientation of every cultural interface, people, organisation as an interface and experiential factor. Learner is exposed to various sub domains of this wide field through various studio assignments and eventually they choose to major in one of the specialised domains.





4.4 Bachelor of Design [B.Des (Textile & Apparel Design), 3 years]

Textile and Apparel Design (TAD) program is a unique program addressing textile, fashion, and interior design requirement in its broadest spectrum. The program strikes a balance in the domains of textile product development and apparel designing. It is deep rooted in scientific process of textile development and garment manufacturing technology. Students will also develop calibre and potential in both traditional handcrafted sector and sophisticated modern technology of textile and apparel industry. The program also strikes a balance with inputs in the areas of the art of design, the science of chemistry and the perspective of history in a rich, challenging learning environment at the creative forefront of the textile industry.

6.4 Campus

The Institute's campus is located at Acharpura Eint Khedi Post, Arwaliya, Bhopal—462038 (MP). The location is well connected with various parts of the country and is located at a distance of 9.5 km from Raja Bhoj International Airport, 15.3 km from Bhopal Railway Station, 22.0 km from Habibganj Railway Station and 17.7 km from the Interstate Bus Terminus.

The institute is situated in 29.49 acre of green campus with the backdrop of hills. The Institute has been designed and structured with innovative ideas to provide a state of the art ambience. The campus has the following facilities:

- Fully furnished separate hostels for boys and girls for a homely stay. Hostels have a common room equipped with TV and indoor games along with modern amenities.
- Well attended medical room with doctors.
- Modern health centre with gymnasium, aerobics, yoga centre, etc.
- Indoor and outdoor sports facilities.
- Auditorium with a seating capacity of 500.
- Amphitheatre with a seating capacity of 800 (under construction).
- Healthy and tasty food served through mess.
- In house residences for faculty and staff to provide 24 x 7 support for students' development.
- Installation of eco-friendly and green initiatives such as solar heating, rainwater harvesting, paper recycling.
- Well maintained and secured campus with CCTV surveillance.

6.5 Infrastructure

To deliver effective teaching in an enabling environment, the Institute has established the following:

- State of the art design studios, seminar halls, classrooms, workshops, tool room and laboratories equipped with latest infrastructure and paraphernalia.
- A modern information technology lab equipped with the required hardware and software.
- Knowledge management Centre with Book Bank Theory, resource centre/library, with a good collection of books, journals, audio-visual learning resources, online resources, etc.
- Specialised labs and studios with required machines and equipments for Foundation studies, Industrial Design Program, Communication Design Program and Textile and Apparel Design Program.



6.6 Administrative Block

Administrative block is a two-storey building with a built up area of 1280 sqm and the façade is covered with stone cladding structure. The block is air-conditioned using VRV Technology, for lesser consumption of energy, and is backed with uninterrupted power supply (UPS). The block also houses a conference hall with a seating capacity of 20 which is equipped with modern audio-video cum presentation system and video conferencing facility.

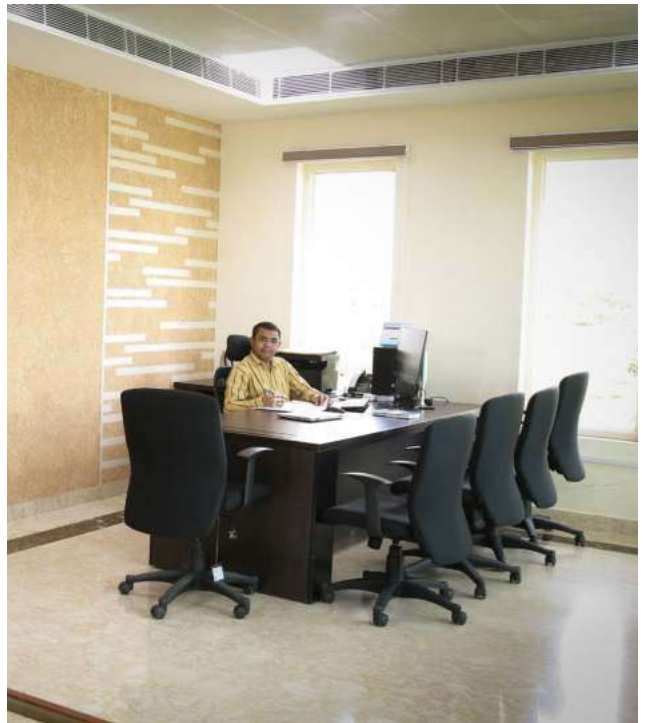

6.7 Academic Block

Academic Block is a three-storey building with a built up area of 4600 sqm with wide corridors that is externally covered with dry stone cladding. Being the hub of academic activities, it has 38 rooms as per the details given below.

- Spaces for teaching and learning activities (inclusive of discipline-specific labs, studios and classrooms) has 09 rooms (03 each on each floor).
- 29 faculty rooms (20 on ground floor and 09 on second floor).
- Design Shop on the ground floor to showcase the artistic works of the students.
- A studio and two classrooms equipped with audio–video cum presentation system.

All rooms are designed with best standards. Entire block is equipped with chiller-based centralized air-conditioning system and has 2 lifts for easy access.



6.8 Workshop Block

The workshop block is a single-storey structure with a built up area of 2100 sqm. This block houses workshops for specialised streams pertaining to Industrial Design (Ceramic, Pottery, Carpentry etc.) equipped with modern hardware and resources these workshops provide learning support to the student community.



6.9 IT Centre

The IT Centre is equipped with best workstations, Cintiq drawing pads by Wacom, IT gadgets, printers, networking, peripherals, etc.



6.10 Knowledge Management Centre (KMC)

The fully air-conditioned, Knowledge Management Centre, is built in an area of 850 sqm. in the shape of an OCTAGON with a ground floor and a mezzanine floor. It houses 2438 books, 405 audio-visual learning resources, and 5000 online magazines.

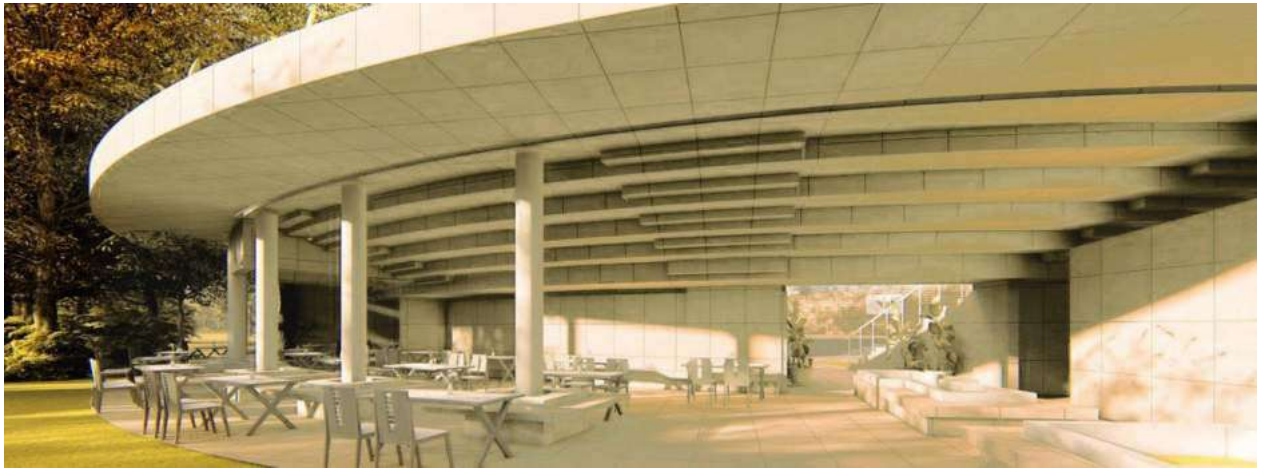
6.11 Auditorium

The auditorium is built in an area of 1200 sqm with a seating capacity of 510. It is fitted with chiller-based air conditioning system and state of the art audio–video technology best suited for conducting grant functions and cultural gatherings.



6.12 Amphitheatre (Under Construction)

A state-of-the-art-amphitheatre, with a seating capacity of 700, is under construction. It will be utilized to organize seminars, conduct recreational activities and other technical events. It will also house cafeteria, discussion rooms, students' shop, etc.



6.13 Hostels (Girls & Boys)

The institute has a provision of separate accommodation for boys and girls. Both the hostels are five-storey structure with a built up area of 6788 sqm. The rooms are designed for single, double occupancy and can accommodate 412 students (176 boys and 236 girls). The rooms are provided with high speed internet connectivity. Hostel has a common dining hall, recreation rooms, television, indoor game facility, automatic washing machines, purified water supply, hot and cold water dispensers, solar geysers and other amenities along with lift facility.



6.14 Mess and Cafeteria

This block is located centrally in between boys hostel and girls hostel for easy accessibility to the students. It has a built up area of 750 sqm with a seating capacity of 120. The dining hall is centrally air-conditioned; the kitchen is fully equipped with modern kitchen equipments and utensils.

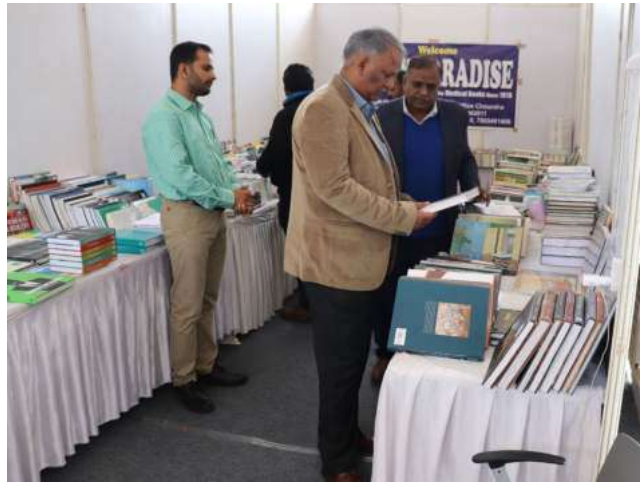

A visit to Bharat Bhawan was organized to witness an art exhibition. The students also visited Islamgarh Fort and Moti Masjid as part of academic activities.

Sports activities

Students actively participated in sports activities such as table tennis, badminton etc and made use of the peripheral road in campus for doing morning/ evening walks. They also made complete use of the fitness equipment

available in the Multi Facility Recreation Centre.

Madhya Pradesh Design Utsav

The event has been conceived to promote and honour Madhya Pradesh as one of the premier Design destinations in India and to acknowledge that formal design education first flourished here. A variety of events, art & craft demonstrations, discussions and competitions were conducted during the first Madhya Pradesh Design Utsav (MOSAIC), which was held between 18 to 20 December 2019. The event witnessed enthusiastic participations from various schools, higher education institutions, industry, government officials and general public.

Wellness

Through constant dialogue and with the help of feedback received from the students, the Institute addressed the following concerns:

- Continued support from faculty and staff
- Mental health issues (depression, mental illness, anxiety, homesickness etc.)
- Provision of campus amenities including hostel and dining
- Strict policies for substance abuse/ misuse
- Provision of sports/ extracurricular activities
- Focus on overall health and well-being

Separate Audit Report on the accounts of National Institute of Design, Madhya Pradesh (NID, MP) for the year 2019-20 and a copy of annual accounts of NID, MP for the year 2019-20 are enclosed. It may please be ensured that this Separate Audit Report is presented to the Governing Body as per rules before presenting it to both the Houses of Parliament. Two copies of the documents submitted to Parliament, indicating the date when they were presented to Parliament, may please be sent to this office and to the office of the Comptroller and Auditor General of India.

Apart from the issues highlighted in the Separate Audit Report, it has also been noticed that the Accounts of NID, MP have been prepared on the basis of format of accounts prescribed vide National Institute of Design (Form of Annual Statement of Accounts) Rules, 2016. Para 3 (2) of National Institute of Design (Forms of annual statement of accounts) Rule 2016 stipulates that the Institute shall follow the general directions by the Central Government in consultation with the Comptroller & Auditor General of India in maintaining the financial statements.

However, the format of accounts prescribed in the said Rule 2016 is not as per the uniform format of accounts prescribed in the Report of the Committee of experts on uniform format of accounts for Central Autonomous Bodies. The following two instances were noticed during the annual accounts audit of NID, MP for the year 2019-20.

- (i) NID, MP has shown the deficit of ₹ 20.69 lakh in Asset side of Balance sheet, however, as per the Uniform Format of Accounts for Central Autonomous Bodies, Surplus/Deficit of Income & Expenditure Account should be transferred to Capital

Fund. The corpus fund should be increased/ decreased by net operating results as shown in the statements of Income & Expenditure.

- (ii) NID, MP has not annexed the statement of Receipts & Payments with the Financial statements, however, the same has also to be prepared and made as a part of financial statements as per the Uniform Format of Accounts for Central Autonomous Bodies.

Although, the Central Government vide Gazette Notification dated 30 December, 2020 has made National Institute of Design, Madhya Pradesh (Form of Annual Statement of Accounts) Rules, 2020, the format of accounts prescribed therein is also not as per the uniform format of accounts prescribed in the Report of the Committee of experts on uniform format of accounts for Central Autonomous Bodies.

It is therefore requested that National Institute of Design, Madhya Pradesh (Form of Annual Statement of Accounts) Rules, 2020 Act may be considered for amendment to adopt the Uniform Format of Accounts for Central Autonomous Bodies in consultation with the Comptroller and Auditor General of India as stipulated in the said Act.

SEPARATE AUDIT REPORT OF THE COMPTROLLER AND AUDITOR GENERAL OF INDIA ON THE ACCOUNTS OF NATIONAL INSTITUTE OF DESIGN, MADHYA PRADESH FOR THE YEAR ENDED 31 MARCH 2020

We have audited the attached Balance Sheet and Income & Expenditure Account of National Institute of Design, Madhya Pradesh (NID, MP) for the year ended 31 March 2020 under Section 19(2) of CAG's (DPC) Act, 1971 read with Section 25(2) of National Institute of Design Act, 2014. The preparation of these financial statements is the responsibility of NID, MP's management. Our responsibility is to express an opinion on these financial statements based on our audit.

2. This Separate Audit Report (SAR) contains the comments of the Comptroller and Auditor General of India (CAG) on the accounting treatment with respect to classification, conformity with the best accounting practices, accounting standards and disclosure norms etc. Audit observations on financial transactions with regard to compliance with the Law, Rules and Regulations (Propriety and Regularity) noticed during the audit of financial statements, if any are reported through Inspection Reports/ CAG's Audit Reports separately.

3. We have conducted our audit in accordance with Auditing Standards generally accepted in India. These Standards require that we plan and perform audit to obtain reasonable assurance about whether the financial statements are free from material misstatements. An audit includes examining, on test basis, evidences supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by the management as well as evaluating the overall presentation of financial statements. We believe that our audit provides a reasonable basis for our opinion.

4. Based on our audit, we report that:

- i. We have obtained all the information and explanations, which to the best of our knowledge and belief were necessary for the purpose of our audit.
- ii. The Balance Sheet and Income & Expenditure Account dealt with by this report have been drawn up in the format approved by the Government of India under sub-rule (1) of Rule 4 of National Institute of Design (Form of Annual Statement of Accounts) Rules, 2016.
- iii. In our opinion, proper books of accounts and other relevant records have been maintained by the National Institute of Design, Madhya Pradesh in so far as it appears from our examination of such books.
- iv. We further report that:

(A) Income and Expenditure Account

Depreciation: ₹ 84.72 lakh (Schedule-6)

Para-1(e) of the Significant Accounting Policies and Notes forming Part of Annual Accounts stipulates that depreciation is calculated on Building at the rate of 2.50 *per cent* on straight line basis. Accordingly, depreciation to be charged on building works out to ₹ 3.21 lakh against which NID, MP has charged depreciation of ₹2.57 lakh only.

This has resulted in understatement of expenditure and overstatement of fixed assets by ₹ 0.64 lakh. Consequently, deficit for the year has also been understated by the same amount.

(B) Grants in Aid

National Institute of Design, Ahmedabad was maintaining the accounts of NID, MP till 2018-19. NID, MP has commenced its first academic session from July 2019 in its own campus at Bhopal, Madhya Pradesh. The position of Grants received, utilized and unutilized is tabulated below:

- v. Subject to our observations in the preceding paragraphs, we report that the Balance Sheet and the Income and Expenditure Account dealt with by this report are in agreement with the books of accounts.
- vi. In our opinion and to the best of our information and according to the explanation given to us, the said financial statements read together with the Accounting Policies and Notes to Accounts, and subject to the significant matters stated above and other matters mentioned in the **Annexure**, give a true and fair view in conformity with the accounting principles generally accepted in India:
- a) In so far as it relates to the Balance Sheet, of the state of affairs of National Institute of Design, Madhya Pradesh as at 31 March 2020; and
- b) In so far as it relates to the Income and Expenditure account, of the deficit for the year ended on that date.

1. SIGNIFICANT ACCOUNTING POLICIES:

a. ACCOUNTING CONVENTION:

The Financial statements are prepared on the basis of historical cost convention, unless otherwise stated and on the accrual method of accounting except for interest income and liability towards privileged leave.

b. INVESTMENTS:

Long Term Investments are stated at cost.

c. FIXED ASSETS:

Fixed Assets are stated at the net value. The cost includes invoice value, freight, octroi, and other incidental expenses relating acquisition.

d. GOVERNMENT GRANTS:

- (i) Government grants are accounted on the basis of sanction from Government Department.
- (ii) Government grant to the extent utilized towards capital expenditure, are transferred to the Capital Fund.
- (iii) Government grants for meeting Revenue expenditure are treated as income of the year to the extent of expenditure incurred.
- (iv) Un-Utilized grants are carried forward and exhibited as a Liability in the balance Sheet.

e. DEPRECIATION:

i. RATE OF DEPRECIATION

Depreciation is calculated on Straight Line Method at the following rates:

- ii. Depreciation on addition has been provided for the full year irrespective of date of acquisition.
- iii Capital Fund account has been transferred to Income and Expenditure account to the extent of depreciation provided on assets acquired out of capital grant.
- iv Depreciation is not provided on assets sold during the year.

f. FOREIGN CURRENCY TRANSACTION:

Transactions denominated in foreign currency are accounted for at the exchange rate prevailing on the date of transaction. The bank balance held in foreign currency is converted into Rupee at RBI rate prevailing on the closing day of the financial year.

g. CURRENT ASSETS, LOANS AND ADVANCES:

In the opinion of the management, the current assets, loans and advances have a value on realization in the ordinary course of business, equal at least to the aggregate amount shown in the Balance Sheet.

h. CURRENT ASSETS, LOANS AND ADVANCES:

i. INCOME TAX:

- (i) The income of the Institute is exempt under Income-tax Act 1961. No provision for Income Tax is therefore made in the accounts.

j. RETIREMENT/TERMINAL BENEFIT

Terminal leave encashment benefit and Death cum Retirement Gratuity (DCRG) to the employees are accounted for on cash basis.

k. STUDENT FEE

- (i) Various fees from Students including Mess charges are treated as income for the year in which these have been realized.
- (ii) Interest on STDR is taken on accrual basis for the year 2019-20, The Total interest on STDRs, inclusive of interest earned on Government Grant, for the year 2019-20 is Rs 12,06,970/-. Out of which actual interest received during 2019-20 is Rs 1,68,557 and accrued interest Rs 10,38,413/- (including TDS of Rs 1,20,732/- deducted) shown as current assets under Schedule 8.

l. CORPUS FUND

NID MP Corpus fund has been credited with the revenue earned from internal sources, including interest earned on STDRs, during the year.

POST SCRIPT I

Genesis of Design in India

The following landmark events/developments can be earmarked as the major forces that led us to the comfortable living of present day.

- The invention of movable printing press by Johannes Gutenberg, a type designer, made possible the mass production of books, posters and pamphlets. It was a revolution in terms of mass communication and certainly was a catalyst for social change.
- The invention of the steam engine triggered the industrial revolution. It impacted all sectors of production process and acted as a tool of mass production. An effective example is the 'no 14 chair' made by Michael Thonet (1859). That is, the wood was heated with steam, bent into the required shape and then made to the shape of a chair by unskilled workers. Designing by planning and conceptualising the manufacturing of the product were separated and thus new discipline of Industrial Design was born.
- Design and Industrial revolution(s)
- Transformation of Design happened exponentially because of industrial revolution and it brought design on forefront leading to all fast developments subsequently. The next stage of industrial revolution is catalysed by the invention of electricity. All the home products were replaced by electric-powered home appliances and this transformed our lifestyle completely.
- An ever expanding user category emerged and their insatiable demand is fulfilled by this new discipline of Product Design. Electric water kettle by AEG, designed by Peter Behrens, in 1909 is a classic example of the first Product Design.
- The latest stage in the industrial revolution is triggered by the use of computers in design process and it transformed present industrial revolution in a big way. This revolution gave birth to two new interconnected disciplines, i.e. Interface Design and Interaction Design. Many digital products and services are more efficient iterations of analogue technology. Word processing software is the digital iteration of a typewriter. We still print books, produce furniture, manufacture appliances and develop software, hardware etc. But digital technology has revolutionized the production aspects of all products.
- In India, after the implementation of Lord Macaulay's educational system in 1835, 'The Schools of Arts and Crafts' were established in Calcutta, Bombay and Madras by the British East India Company around 1854. These schools modelled on contemporary British schools of Arts and Crafts were considered as the forerunner of design schools in India.
- Post second world war, British arts and crafts schools remodelled their education model more aligned to Bauhaus influences. However, Indian counterpart continued to focus on Pure art-based education.
- In 1900 a new school modelled on the ethos of Bauhaus philosophy and Machine Aesthetics' got established by a group of few artists and is called as 'The Bengal school'.
- In 1922 an exhibition by Bauhaus masters and students of Weimar period was showcased at the headquarters of the Indian society of Oriental art in Calcutta and was reported in prestigious journal of culture, Rupam.
- Rabindranath Tagore, who got influenced with this exhibition established 'Kala Bhawan' at Visva Bharti in Shanti Niketan.
- Around 1930s, the popularity of this school spread far and wide, famed as Shanti Niketan, it influenced and gave birth to many other schools in the country.
- After independence, India laid a strong foundation for all educational and technological institutions. Following this path new design institutes were established in India.
- India is home to vast art and craft traditions dating back to second millennium BCE. Many of the craft traditions stood the test of the time despite modernization. These art and craft forms survived in their original form.
- The conceptualisation of NID has become a transitional bridge amongst these old art & craft traditions and the new machine-based designs and products.

-
- In 1952, Le Corbusier was commissioned by the Indian Government to design and build a new capital of the state of Punjab. He also designed four buildings in Ahmedabad. These structures influenced the education model of Architectural studies in India.
 - In 1953, The Industrial Policy Resolution was passed and it gave emphasis to accelerate industrialisation and nurture growth of public and cooperative sectors. This was done to increase the employment opportunities and to improve the living standards and working conditions of the people.
 - Industrialisation became the new norm, it was obvious that sooner or later, modern design would become a necessity. Realising this, The National Institute for Industrial Design (later called as National Design Institute) was set up in 1961.
 - The Ford Foundation representative Douglas Ensminger, on 6 May 1958, in his report to the Foundation stated that the small industry planning team from the United states that had visited in 1954 was the first to recommend that a school of Design should be established in India. The Government of India accepted this recommendation.
 - In 1956, MoMA Exhibition (Textiles and Ornamental Arts of India) organised by The MoMA in New York brought together Charles Eames (renowned American Industrial Designer) and Pupul Jayakar (prominent supporter of India's Craft traditions and founder of Indian Handlooms and Handicrafts Export Council IHHEC, Cultural advisor to Indian Government). They played a significant role in ushering Design movement in India.
 - Monroe Wheeler (Director of Exhibitions and Publications at MoMA visited India in 1956 and convinced Ministry of Commerce and Industry to bring to India a travel Exhibition on industrial Design. Hundred best Design Products of the world (in 1961 the entire collection was transferred to NID s unique prototype collection)
 - The response and feedback of Indian designers and craftsmen compelled government of India to consider establishment of an institute of Design.
 - Charles and Ray Eames travelled across the remotest locations in India to interact with philosophers, writers, sociologists, craftspeople, architects, scientists and industrialists. A report based on their observations and findings was presented to the Indian government on 7 April 1958.
 - This report is considered as the formal background note for setting up an Indian Design school to acknowledge and address the various design perspective and to create job opportunities. This report advocated the establishment of an indigenous design legacy that exhibits a judicious application of both modern disciplines and old traditions to meet the challenges of contemporary India.
 - Pupul Jayakar played a key role in bringing together the forces that were finally responsible for setting up of the institute.
 - Indian government owes a lot to the initiatives of Ford Foundation in India in establishing NID. Gira Sarabhai, sister of Vikram Sarabhai Gautam Sarabhai played a significant role in opening of the first NID office on 1 November 1961. It was inaugurated on 3 November 1962.
 - Initially NID operated from Calico Mills campus and then shifted to top floor of Sanskar Kendra (managed by Ahmedabad Municipal Corporation) for the next 5 years.
 - In 1967, institute moved to its current Paldi campus.
 - The National Institute of Design (Ahmedabad) officially came to existence on 1961 on 20 acres of land. It was registered as a society under the societies Registration Act, 1860 and also under the Bombay Public Trusts Act, 1950 by the Government of India, in the Ministry of Industry (now known as Ministry of Commerce and Industry), as an autonomous institution. The institute is mandated to provide education at graduate and postgraduate level.
 - The Logogram for the institute is designed by Adrian Frutiger in 1965 and the name was finally changed to National Institute of Design (erstwhile known as National Design Institute).
 - In 1965, first postgraduate programme in Visual Communication commenced.

- In 1966, first postgraduate programme in Product Design commenced.
- In 1968, first postgraduate programme in Textile Design and Ceramic Design commenced.
- In 1969, first postgraduate programme in Furniture Design commenced.
- In 1970, first professional education programme in Industrial Design and Visual Communication commenced.
- International Design fraternity participated in building this iconic institution through seminars, discussions, workshops and consultancies. Some of the key programmes and contributors who participated in this institution building, faculty and programme development exercise are mentioned below.
- Around 1960s, 62 workshops were planned on the lines of the infrastructure at the Royal College of Art London. Hochschule Fur Gestaltung Ulm, Department of Environment design, University of California, Berkeley James Prestini, Design teacher, Department of Architecture, University of California, Berkeley helped in setting up the workshops by giving machine specifications and plan machine layouts.
- P P Hancock, former foreman from the Royal College of Art, London was appointed to set up the wood Workshop of NID in February 1966.
- Two Swiss experts Manfred Merz (Offset printing expert) and Eduard Schmid (Plate and Block making and process camera expert) trained technicians of printing department.
- Ford Foundations funded to invite foreign consultants for the training of NID staff abroad.
- Jesse Reichel (Consultant from University of California Berkeley) submitted his proposal to Governing Council on the concept of in service training. He emphasised that practice is the most enduring means of educating designers both at student apprentice and at the staff level. This gave birth to the concept of Project-based training (professional practice of staff and students) in academic activities as a mandatory preposition.
- James Prestini Walter Gropius, Leo Lionni George Nelson, Dean J Luis Sert Erik Herlow and Ernst Scheidegger were consulted extensively to train the faculty members and to develop the curriculum structure for various disciplines. Other consultants were Louis Kahn, Richard Berteaux (UCLA), Maxwell Fry. Their contributions made huge contribution in developing a unique culture at NID. Other contributors are major Joan Erikson, Charles Eames, Saul Bass, Norman McLaren.
- After the completion of first and second batch of Visual communication, P M Dalwadi was sent to Switzerland, Germany, Italy, France and England for advance training in Photography, Ishu Patel and Mahendra C Patel underwent further training at Basel, Switzerland and also in Type Design in Paris, Vikas satwalekar went to Basel for advance training.
- In 1962, Armin Hofmann (Head, Department of Graphic Design, Allgemeine Gewerbeschule Basel, Switzerland) spent 6 months at NID to start Graphic Design course. His wife Dorteia Hofmann also taught a course in Letter Design.
- Fridolin Muller (Art director, Grafiker SWB Zurich), Peter Teubner (German Scholar, Basel), Hans Christian Pulver (Basel) taught Graphic Design and typography. Bruno Pfaffi (Academy of Plastic Arts, Paris) taught Typography. Adrina Frutiger (type Designer, Lécole Estienne, Paris) taught Type Design. Frutiger, through his workshops, influenced the development of Hindi script typeface Devanagiri and other Hindi scripts.
- Igildo Biesele (Professor, Graphic Design, Basel) helped to develop curriculum of Visual Communication.
- Armin Hofman trained three graduates from first batch on Graphic Design, Letter Design and Typography. These graduates also observed the teaching methodology, practice, and culture of Basel, Switzerland.
- Bob Gill (American Illustrator and Graphic Designer, Design Consultant Royal College of Art London), Alan Fletcher and Colin Forbes visited NID and contributed in developing the Graphic Design competencies in 1962.
- In 1964, Christian Staub (Former photographer, Ulm School HfG, joined NID

as consultant for Photography. In 1960s Henry Cartier Bresson (renowned French Photographer) also visited NID. Around this time Robert Anderson (American Photographer) also joined as consultant at NID for Photography.

- In 1966, Eminent filmmakers John Hallas (UK), Leo Lionni and Giulio Giannini (Italy) Norman McLaren (Canada) were invited to set up Animation Design Discipline.
- In 1966, Hans Gugelot (Professor, Product Design, Ulm school and consultant Designer from West Germany) helped in developing Product Design Discipline. Hans associate E.Reichl also from Ulm spent a month at NID and with the help of his associates Diener and Herbert Lindinger (Department of Product Design, Ulm) articulated the curriculum.
- In 1966, first common course Professional Education Program (PEP) at NID was developed as Design Foundation studies.
- Students of Graphic Design after finishing their programme were sent for a unstructured 'rounding off experience' to Basel or Paris or United states, whereas Product Design students went for their Diploma Projects, which were sponsored by the industry and these were structured projects monitored by the institute.
- Around 1966, few alumni of IIT, Mumbai helped to start their IDC department and most of them joined the department to teach design.
- Mischa Black and Bruce Archer (Renowned Designers and Professors at Royal College of Art, London) mentored the alumni.
- Arno Votteler (Head, Department of Furniture and Interior Decoration, Braunschweig Design school, Germany) based on recommendation of Ernst Reichl from Hans Gugelot was appointed as Consultant in conceptualising Furniture Design Programme. He was succeeded by his associate Rolf Misol and Maxmilian Janisch (Votteler's institute) in developing the furniture programme.
- George Nakashima (Renowned American Architect and Furniture Designer) helped to set up the Furniture Design discipline. Tapio Wirkkala (Finnish Furniture Designer) also taught about furniture design. Faculties were sent to Copenhagen for training of Furniture making.
- Haico Nitzsche (renowned creator of Ceramic forms, Gustavsbergm Sweden) in 1968 initiated the postgraduate programme in Ceramic Design. Hans Theo Baumann (Leading Ceramic Designer, Salone international Ceramics, Venice) continued the legacy of managing the programme, and he was succeeded by his associate Lutz Zettler to run the programme.
- In 1964, Frei Otto (Institute of Light Weight structures, Stuttgart, helped to conduct a study on Light-weight structures (for architecture program). The other invited foreign consultants were Louis Kahn (Professor of Architecture, University of Pennsylvania), Enrico Peresutti (Milan), Harry Weese (Chicago), Claude Stoller (Professor, College of Architecture, Berkeley) and Heinrich Kosina (Airport Planning Consultant, Munich).
- NID faculties were sent on deputation to work in the offices of consulting architects and some of them are Louis Kahn (Philadelphia), Persutti's office (Milan), Harry Weese. The Architecture program was withdrawn in 1969.
- NID Ahmedabad is home to state-of-the-art infrastructure right from its inception. Some of its prestigious possessions are stated below.
 - i. Oxberry Camera (an Archival piece now)
 - ii. 'Hundred best Design Products of the world. (Since 1961 the entire collection is on permanent display at NID.)
 - iii. Thorens turntable, AKG microphones, Ampex ¼" magnetic tape recorders, Tannoy speakers, Nagra ¼" recorders.
 - iv. Small Leclerc loom from America.
- As we have seen that NID, Ahmedabad has emerged to become the foremost multi-disciplinary institutions in the field of design education, applied research, training, design consultancy services and outreach programmes. NID has also been recognized as a Scientific and Industrial Research Organisation by the Department of Scientific and Industrial Research, Ministry of Science Technology, Government of India.
- In 2005, NID Gandhinagar Campus was

set up and later in 2007 the NID Bengaluru Campus was set up.

- In 2007, Department for Promotion of Industry and Internal Trade (erstwhile Department of Industrial Policy and Promotion), Ministry of Commerce and Industry, Government of India had envisioned the National Design Policy aimed at creating a design enabled innovation economy and strengthening design education in the country.
- Department related Parliamentary standing committee on commerce, after many deliberations, visits to Campus and interactions with faculty, students, alumni and other design fraternity submitted its report on 13 August 2013. Report no is 111 on National Institute of Design Bill, 2013.
- The report was presented to the Rajya Sabha on 26 August 2013 and later laid on the table of Lok Sabha on 26 August 2013.
- 17 July 2014 is considered as the golden day for Indian Design education as President of India gave his assent to the National Institute of Design Bill, 2014 and notification to declare NID as an 'Institution of National Importance' and was published in Government of India's Gazette on 18 July, 2014. The NID Act 2014 came into force with effect from 16 September 2014.
- During discussions before passing the NID bill, in the two Houses, members appreciated the activities of the institute and unanimously agreed to pass the Bill. NID is now authorised to deliver degrees and offer PhDs.
- NID also joined the elite group of institutions by becoming 41st Institution of National Importance.
- On 6 March 2007, the National Design policy was published, and a committee was constituted with representatives of various ministries and departments with Director, NID, Ahmedabad as Member Secretary.
- The final recommendations of the committee helped to constitute the Design Council of India, form a Chartered Society of Designers, form a Working Group for new Institutes of Design and strengthening of Design Education in existing institutions, and conduct Design Awareness Programmes across the country.
