| Reply 1 | <p><b>Cohort A – Punishment:</b><br/>Suspension from classes and Academic Privileges (contact hours with Faculty and usage of workshop and Library) and suspension from Hostel (to be imposed concurrently) will be imposed on the students coming under Cohort -A.</p> <p><b>Cohort B – Punishment:</b><br/>Students coming under Cohort – B are given punishment of community service (coaching/ mentoring/ workshop/ cleanliness/ beautification of premises) in a primary school for 8 weekends (minimum 60 hours). They must submit a report of community service supported by photographs and letter with feedback from head of the primary school during the current semester.</p> <p>Ms. Medhanjali Singh, Ms. Priyatam Gaddam and Ms. Yaga Varshini were put under Cohort – B. Accordingly they were awarded punishment as mentioned under Cohort – B above.</p> |
