1. * Declaration given by the bidders that the turnover is below Rs. 20 Lakhs up to this date so GST Registration is not applicable.
2. ** Bidders at S. No. 4, 8, 10, 12 and 16 did not submitted the mandatory documents as per tender terms & Conditions.
3. *** Annexure 1(Financial offer) submitted by the bidder at S. No. 10, 12 & 16 is not in proper format.

It is informed that for evaluation of the tender of "Internal Auditor for the Institute" the committee received total 33 envelopes from the Administrative Department, out of which the subject was not mentioned on 03 envelopes, upon opening them the committee came to know that 02 the envelopes pertain to the Inviting Quotation for Annual rate Contract for Consultancy services for E-filing of GST/ IT TDS/Professional Tax/ Filing of IT Return and other taxation related matter for the year 2022-23 and onwards. Therefore, both quotations have been included in the report, which is showing in pre-page serial no. 15 and 16.

M/s Shankar Lal Agrawal & Co. Jabalpur has submitted a DD Amount Rs. 5000/- with DD No. 156585 Dated 16.04.2022 Bank Name – INDIAN BANK. M/s R. C. Baheti & Co. Bhopal has submitted a DD Amount Rs. 5000/- with DD No. 022046 Dated 13.04.2022 Bank Name – UNION BANK. The above two DD is enclosed with their documents submitted by them along with file.

Thus, on the basis of details mentioned on pre-page and above the committee unanimously recommends that the work may be allotted to Bidder at S.No.9 at Rank-11 to **M/s JNRG & Associates, Bhopal**, after the approval of the Competent Authority.
