 - (ii) Date of birth certificate.
 - (iii) Marksheets and Certificates in support of the prescribed educational qualifications.
 - (iv) Experience Certificate as mentioned in your application (clearly indicating designation, from (date) pay details, etc. offer of appointment shall not be accepted as proof since the duration of service, etc can't be ascertained) as applicable.
 - (v) Caste/category certificate i.e., SC, OBC, EWS, PwD, ESM etc., if applicable
 - (vi) Certificate in support of age relaxation, if applicable.
 - (vii) No Objection Certificate from the present department, if working in Govt organization/Autonomous bodies/PSUs etc.
