- (iii) Degree, Marksheets (year wise) and Certificates in support of the prescribed educational qualifications
- (iv) Experience Certificate as mentioned in your application (clearly indicating designation, from (date) pay details etc. offer of appointment shall not be accepted as proof since the duration of service etc can't be ascertained)
- (v) Caste/category certificate i.e. SC, OBC, EWS, PwD, ESM etc. if applicable
- (vi) Certificate in support of age-relaxation. (if availed)



- (vii) No Objection Certificate from present department, (if working in Govt organisations/Autonomous bodies/PsUs etc.)
- (viii) Copies of Annual Performance Appraisal Report (APAR)/ACRs of last five year from your employer, (in case of deputation candidates.)
