- (v) Caste/category certificate i.e. SC, OBC, EWS, PwD, ESM etc. if applicable
- (vi) Certificate in support of age-relaxation.
- (vii) No Objection Certificate from present department, if working in Govt organisations/Autonomous bodies/PSUs etc.
