- Certificate in support of age-relaxation. (vi)
- No Objection Certificate from present department, if working in Govt organisations/ (vii) Autonomous bodies/PSUs etc.
- Failure to produce the original and prescribed documents in support of eligibility criteria (viii) for the post at any stage shall debar the candidate for appearance in the recruitment process for the post. No representation shall be entertained in this regard.
