- (ii) Date of birth certificate.
- Marksheets and Certificates in support of the prescribed educational qualifications (iii)
- Experience Certificate as mentioned in your application (clearly indicating (iv) designation, from (date) pay details etc. Offer of appointment shall not be accepted as proof since the duration of service etc can't be ascertained) as applicable.

- Certificate in support of age-relaxation.
- No Objection Certificate from present department, if working in Govt organisations/ (vii) Autonomous bodies/PSUs etc.
