## Corrigendum to Tender No. NIDMP/Mess-Catering/09/2020 dated 28.09.2020

1. Reference NID MP tender No. NIDMP/Mess-Catering/09/2020 Dated 28.09.2020. The following changes in the tender notice are hereby notified through this corrigendum to all concerned advertisers and stakeholders:

(i)	Labour license from the State Labour Department is required for works having more than 20 persons. As more than 20 persons are not required to be employed here; it is requested that the requirement of having a labour license should be done away with.	The requirement of having a labour license for less than 20 persons stands removed.		
(ii)	As the Institute will be paying the mess charges for 10 months, it is requested to charge rent for 10 months only.	Rent shall be charged for full 12 months. However, 50% waiver on Mess Rent will be given for the remaining two months.		
(iii)	A provision of 10% increase in rental charges has been mentioned in the tender, whereas in each year 10% reduction in the rate of mess charges for students has been given. It is requested that the rate of messing should also be increased by 10% every year keeping the increase in rates of commodities in mind. Or there should be no increase in the rate of rent.	Since the number of students would increase in next two years as detailed in Tender Document, the point is not accepted.		
(iv)	The provision of award of work to more than one contractor is requested to be done away with as the work is very small.			
(v)	The Institute is requested to provide rent free accommodation to the labour during the period of contract.	The Institute shall provide accommodation @ a nominal amount of Rs 2000/- per month to the labour. An increase of 10% per year on this amount shall be admissible.		
(vi)	As per financial bid lease rent was asked & 10%	The bidders shall refer "Scope of Work
