


**Subject: Joint Coordination Committee of NIDs – meetings regarding.**



Record of Discussion of the Meeting held on 7<sup>th</sup> June 2022 at 11:00 AM under chairmanship of Secretary, DPIIT regarding the issues (i) to explore whether all existing educational Institutes under the Department can be shifted to Education Ministry/Skill Development Ministry, etc.; and (ii) increasing intake capacity and utilizing unutilized infrastructure.

A Meeting under the Chairmanship of Secretary, DPIIT was held on 7<sup>th</sup> June, 2022 at 11:00 AM with Directors of NIDs and FDDI to discuss the issues related with following Agenda items:

- i. To explore whether all existing educational institutes under the Department can be shifted to Education Ministry/Skill Development Ministry, etc.; and
  - ii. To explore possibility for increasing intake capacity and utilizing unutilized infrastructure.
2. List of participants is enclosed as Annexure.
3. Based on the discussion held during the meeting, following action points emerged:

- i. In view of the opinion of all the NIDs and FDDI 'to be kept under the DPIIT', the likely benefits by transfer of NIDs and FDDI to Ministry of Education may be explored and necessary support may be provided by DPIIT to extend such benefits to these institutes as feasible. The Directors of NIDs and MD, FDDI will submit self-contained proposal, providing justification to DPIIT as regards to support needed from DPIIT for the same clearly bringing out the financial and non-financial aspects.

(Action: All NIDs, FDDI)

- ii. All NIDs shall discuss the issues related to design-education in 'coordination-meeting' on monthly basis. Joint Secretary, DPIIT shall be invited to participate during the second leg to discuss the issues wherein intervention/ support of DPIIT would be required. Similar exercise may also be done by FDDI.

(Action: All NIDs, FDDI)

- iii. The budgetary supports being provided by DPIIT under the Capital Head to the NIDs are not being utilized fully during the last few years. All NIDs and FDDI shall prepare and submit a visioned financial proposal in order to equip the institute with State-of-the-Art infrastructure.

(Action: All NIDs, FDDI)

- iv. All NIDs shall prepare a common visioned plan in order to get the institute enlisted among top global design educational institutes in next 5 to 10 years. Similar exercise may also be done by FDDI.

(Action: All NIDs, FDDI)

- v. In case of any IPR related issue, the officers from O/o CGPDTM may also be invited during the coordination meetings of NIDs/FDDI.

(Action: All NIDs, FDDI, DPIIT)

- vi. All NIDs/FDDI shall explore the possibilities to commence short term courses viz. certificate course etc. for better utilisation of the available resources with NIDs/FDDI. The recommendation/ suggestions in this regard may be submitted to DPIIT which may be discussed during next meeting to be chaired by Secretary, DPIIT.

(Action: All NIDs, FDDI, DPIIT)

- vii. All NIDs and FDDI shall explore the possibility for better utilization of available resources and infrastructure and make a presentation during the next meeting to be chaired by Secretary.

(Action: All NIDs, FDDI, DPIIT)
