The proposal for implementation of NPS at the Institute has been approved by the DPIIT vide its letter dated 15.06.2020. Subsequently, the PFRDA has approved the NPS proposal vide its letter dated 17.08.2020 and also the registration of various authorities like Pr. AO, PAO, DDO has been completed by the NSDL.

Further, as on date, an amount of Rs 51,33,329/- (Annexure-A) has been accumulated as NPS contribution of the Institute employees, which needs to be deposited to the respective PRAN (permanent retirement account number) of the employees. In this regard, the following is submitted for kind consideration and perusal please:-

1- The employer contribution was contributed @ 14% till March 2020. however, as per the instructions of Ministry, only 10% NPS contribution needs to be contributed and deposited till the approval of MoF on the enhanced contribution of 4% (14%-10%). Accordingly, it is proposed to deposit the employer share @ 10% instead of 14% up to March 2020. The disposal of rest of amount will be decided after the approval of Ministry on the matter.

2- Some employees already have their PRAN card issued from previous organization. The contribution of NPS (employer share @ 10% only) till date may be shifted to their existing PRAN number after shifting of DDO. The contribution of rest of the employees will be shifted to their respective PRAN after issuance of new PRAN to them from NSDL.

3- The NPS Contribution of an amount of Rs 1,87,986/- (@ 10% employer share) for Mr. S. C. Thakur, Ex-CAO, for the period of their service in the Institute, may be transferred to his current employer IIT Indore through Demand Draft.

Flag 'A' is a letter dated 15.06.2020 received from the DPIIT conveying approval for implementation of NPS at NID MP having specific approval to contribute 10% employer share. Consequently, an agenda item no. 9 was placed before Hon'ble Governing Council (GC) in its 3rd meeting held on 08.12.2020 for consideration and approval of enhancement of employer contribution to 14% in terms of notification dated 31.01.2019 issued Department of Financial Services (DFS), MoF for Central Government employees. However, after deliberation, the GC didn't agree on the proposal and instructed as "it was communicated to the institute that Ministry of Finance has issued directives to all concerned ministries to implement NPS employer share @ 10% for Autonomous Bodies" vide approved minutes dated 30.12.2020. (Flag-B).

Subsequently, Department of Expenditure, MoF has issued instructions on applicability of notification dated 31.01.2019 issued by DFS, MoF to the employees of Central Autonomous Bodies, resulted enhancement of employer share to 14% under NPS, vide its OM dated 26.08.2021 (Flag-C), which may please be seen for reference. A discussion on implementation of above OM dated 26.08.2021 was held with the Director on 22.09.2021 and it was instructed to implement the above said OM for institute employees. Further, it was also instructed to place an agenda item to get it ratified from Governing Council in its next meeting. 'A'

Accordingly, as per above instructions, the proposal for implementation of DOE, MoF OM dated 26.08.2021 for enhancement of NPS employer share to 14% for Institute employees is submitted for consideration please.

PFA is an OM dated 23.06.2022 (F/A) received from DPIIT having subject "Approval for applicability of Gazette Notification no. 1/3/2016-PR, Dt. 31.01.2019 issued by DoFS, MoF to the employees of NIDs-reg". The DPIIT has observed that the applicability of Gazette notification dated 31.01.2019 (F/B) issued by DoFS, MoF regarding enhancement of share of contribution of NPS, from 10% to 14% has been implemented by the NID, MP suo moto. Further, it was instructed to submit the proposal as per provisions contained in the DoE, MoF OM dated 26.08.2021 (F/C) duly including the financial estimates/implications for consideration of ex post facto approval. Further, it was also instructed to clarify whether the said provision was implemented by the institute after the approval of the concerned GC.

The matter was examined as per the MoF OM dated 26.08.2021 (F/C) and MoF OM dated 13.01.2017 (C/D). In this regard, it is submitted that the enhancement of employer share from 10% to 14% towards NPS contribution for regular employees was implemented after the issuance of MoF OM dated 26.08.2021 extending the provisions of gazette notification dated 31.01.2019 to the employees of Central Autonomous Bodies. The MoF OM dated 13.01.2017 having guidelines on "Pay revision of employees of Quasi-Government/ Autonomous Organizations, Statutory Bodies etc. set up by and funded/controlled by the Central Government" has issued instructions for sharing of financial implication of the revision of pay consequent upon 7th CPC implementation on such organizations which has been reiterated by the DPIIT vide its email dated 14.06.2022 on seeking administrative and financial approval on the proposal of enhancement of NPS employer contribution from 10% to 14%.

Accordingly, it is proposed to submit a proposal as per provisions contained in the DoE, MoF OM dated 26.08.2021 (F/C) and OM dated 13.01.2017 (F/D) having financial estimates/implications of the proposal of enhancement of NPS employer contribution from 10% to 14% for the regular employees of the Institute for consideration of ex post facto approval of Administrative Ministry (DPIIT).

If, approved, the DFA of the proposal cum request letter to DPIIT attached at (F/E) may please be seen for consideration/ perusal and approval/modifications, if required.

The DPIIT has sought the reply of the Institute on the below mentioned query raised by Internal Finance Wing (IFW) of the DPIIT: -

"As per D.O. letter dated 19.07.2022 of Pension Fund Regulatory and Development Authority, NPS cannot be implemented in Central Autonomous Bodies without concurrence of DoE. From the note, it is obvious that NPS has been implemented in all four NIDs (AP, Assam, Haryana & MP) except Ahmedabad. But, from the note, it is not clear, whether while implementing NPS in four NIDs, concurrence of DoE was obtained or not? AW is requested to clarify this."

The matter was examined as per the MoF OM dated 26.08.2021 (F/C) and attached PFRDA letter dated 19.07.2022. In this regard, a draft of the letter, having reply on the above query, addressed to Under Secretary (NID Section), DPIIT is attached at (F/D) which may please be seen for consideration/ perusal and approval/modifications, if required.
