Subject: Revised Information / Instructions for the candidates appearing for the various posts of Faculty.

1. Reference is made to the Advt. No. NIDMP/1-70/ (13) Rectt. -Faculty/2025 dated 13.03.2025 for Faculty positions at National Institute of Design, Madhya Pradesh and earlier notification No. 13/2025 on the subject.

2. Candidates who had applied for various faculty positions in response to the above-cited advertisement and were subsequently notified as Eligible/Provisionally Eligible in the Final List, shall be eligible to appear for the Document Verification Process followed by Interview (subject to the successful document verification) as per the notified schedule.

3. The Interview process overview/format is appended below for information of candidates.

Overview	Methodology
(a) Domain Knowledge / Skill relevant to the post (Max. Marks 07)	Cross-examination by the Statutory Selection Committee (SSC) about your domain knowledge / skills.
(b) Professional experiences, current roles, and responsibilities (Max. Marks 06)	Cross-examination by the Statutory Selection Committee (SSC) to understand your role in various assignments during your entire career & you will be asked to present a video / PowerPoint presentation introducing yourself / showing year-on-year Personal Development Portfolio of your career relevant to the post. You need to prepare this video/presentation and present it to the SSC during your interview. The duration of video / presentation should be 7-10 minutes maximum.
(c) Communication Skills, Leadership qualities. (Max. Marks 06)	Cross-examination by the Statutory Selection Committee (SSC) to evaluate your communication skills, professional attitude, and leadership qualities.
(d) Personality, adaptability, etc. (Max. Marks 06)	Observations made by the Statutory Selection Committee (SSC).


4. It is specified that the minimum qualifying marks for qualifying in the interview shall be 15 Marks out of a total of 25 Marks, scoring a minimum of 03 marks in para 3(a) and 2.5 marks in para 3(b) to (d) of the domains stated at Para 3 a) to d) above.
